

PREQUALIFICATION NOTICE

NOTICE INVITING TENDER FOR PRE-QUALIFICATION OF CONTRACTORS

Improvement and Widening of Road Network from Sea Port Karachi to Thar Coal Field Area via Thatta, Badin, Wango, Mithi, Islam Kot (Phase I) upto Wango Mor 225 Km.

- Sindh Coal Authority has received funds from Province for the Project cited above with Scope, Estimated Cost and other details are as under:-

(i) **Scope:** To develop the Thar Coal Field, the Construction of Infrastructure especially the road network is required to be of such standard to sustain expected heavy axle loads. Considering the requirement of heavy vehicles the Government of Sindh, Coal Energy Development Department/Sindh Coal Authority has therefore decided for widening / improvement / strengthening the existing road network which lead to Thar Coal).

(ii) **Estimated Cost:** Pak Rs. 3,000 million

(iii) **Project Completion Period:** 18-21 months.

(iv) **Bidding Process:** National Competitive Bidding (NCB)
