Otherwise their tender will be summarily rejected without consideration of their bid amount.
- The successful bidder will furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 5% of sanctioned cost. This guarantee will be released after completion of work.
- An amount equal to 5% from each bill will be deducted as Retention Money. which will be released after successful expiry of maintenance period.
