
1. Tender schedule shall be as follows:

- In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 15-05-2012 and the tender documents will also be available upto 14-05-2012.
- The tender documents / BOQ (Schedule-B) alongwith minimum qualification criteria (Volume-II) will be issued to the firms on submission of application in their original letter head alongwith Pay Order of Tender Cost in favour of K.M.C as mentioned above. Whereas the standard bidding documents (Volume-I) including instruction to bidder, bidding data, condition of contract, contract data, etc is available on (Defunct) CDGK website (www.karachicity.gov.pk).
- The Bid Security as mentioned above in shape of pay order in favour of K.M.C shall must be enclosed with tender documents without which the tender will be treated as cancelled.
- The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will be not accepted. In addition, the bidders must furnish the documentary evidence against each eligibility criteria as mentioned above with there bid. Otherwise their tender will be summarily rejected without consideration of their bid amount.
- The successful bidder will furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 5% of sanctioned cost. This guarantee will be released after completion of work.
- An amount equal to 5% from each bill will be deducted as Retention Money, which will be released after successful expiry of maintenance period.
