**TERMS AND CONDITIONS**

1. Tender forms can be obtained from office of the Directorate following the day of publication of this notice, on written request to the Director and on payment of non refundable tender form cost of Rs. 1,000/- (in cash) on any working day from *the publication* 2012 between 9 AM to 4 PM.
2. The total bid as well as the rate of items must be filled both in FIGURES and WORDS and in case any correction is made by the contractor himself, then each correction must be initialed by the contractor.
3. The number of Items could be increased or decreased on need assessment basis.

4. The supplier shall pay all such expenses, costs, charges, taxes, duties and / or levies as may be payable for completing the required work.
5. The rates offered should be valid for 60 days from the date of opening the tender.
6. Sealed tenders in alongwith 2 ½ % bid money in the shape of pay order/ demand draft from any scheduled bank in favour of Director Women Development Sindh, should be dropped in the box placed for the purpose at the address mentioned below.
7. The pay order of Bid Security of first, second and third bidders will not be returned till finalization of the case.
8. Conditional tenders will not be accepted.
9. Tenders will be received on *8/12* 2012 at *12.00* PM and will be opened on the same day at *10.00* PM by the TENDER OPENING COMMITTEE in the office as mentioned below in the presence of bidders or their authorized representatives who care to be present. In case the opening date is declared as a public holiday by the Govt. the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.

11. The procuring agency may reject all bids or proposals, at any time prior to the acceptance of a bid or proposal subject to the relevant provision of Sindh PPRA rules. The procuring agency shall upon request communicate to any supplier or contractor, who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
12. Items should be brand new and unused. Attach catalogue/technical literature.
13. Indicate warranty period.
14. Any dispute or difference relating to this contract shall be settled by a sole arbitrator to be mutually nominated, in accordance with the provisions of the Arbitration Act.1940 and any modification or re-enactment thereof. The arbitration shall be conducted at Karachi.
