- Blue Line (New Sabzi Mandi, Super Highway to Tower) to serve as MRT (Elevated/Under Ground)
- Development / Prioritization of Road network for Karachi city for Short Term (2015), Mid Term (2020) and Long Term (2030) with appropriate cost estimation for Budget allocation in future Years
- 3. Comments on Interim Report 1 & Interim Report 2 (other than KMTC Comments)

Interested firms are invited to submit Expression of Interest (EOI) for the above assignment along with updated renewal, in relevant category.

- Details of Consortium / Association, Applicants may note that any consortium must not comprise more than three (03) individual firms,

- Details of projects in Mass Transit, public transport and Transportation Planning during last five years with proof.

In case of no litigation and / or blacklisting history, the firm / consortium joint venture will provide Affidavit duly endorsed by Notary Public on a stamp paper of Rs.100/- otherwise submit details of such cases and their present status.

The consultancy cost of the above mentioned studies is fixed and will not be more than Rs.990,000/= in any case.

Interested firms registered with Pakistan Engineering Council with updated renewal are required to prepare their EOI based on above guidelines.

The EOI documents shall be submitted to the office of Director General, Karachi Mass Transit Cell, KMC 6<sup>th</sup> floor, East Annexe Building, Civic Center within 15 days of the publishing of the advertisement.
