- 02. The total bid as well as the rate of items must be filled both in FIGURES and WORDS and in case any correction is made by the contractor himself, then each correction must be initialed by the contractor.
- 03. The number of Items could be increased or decreased on need assessment basis.
- 04. The Supplier shall pay all such expenses, costs, charges, taxes, duties and/ or levies as may be payable for completing the required work.
- 05. The rates offered should be valid for 60 days from the date of opening the tender.
- 06. Sealed tenders in along with 2 ½ % bid money in the shape of pay order/ demand draft from any scheduled bank in favor of Director Women Development Sindh should be dropped in the box placed for the purpose at the address mentioned below.
