**REQUEST FOR EXPRESSION OF INTEREST (EOI) / PREQUALIFICATION OF
CONSULTANTS**

1. PROJECT BACKGROUND:

Sindh Coastal Community Development Project (SCCDP) an ADB funded project under its GIS component intends to invite Expression of Interest (EOI) for the six months consultancy services for “**Development, Maintenance & Training for the Flood Monitoring Application**” through “Quality and Cost Based Selection Method”, under SPPRA rules 2010.

2. Objectives: The said application will assist the project in

- (i) Mapping of damage caused by natural hazards
- (ii) Development of prediction model for future patterns of hazards i.e. cyclones, floods or and sea intrusion
- (iii) Planning of development activities in coastal areas.

3. Area of Interest (AOI): The consultancy will cover the Area of Interest (AOI) of the project encompasses the districts of Thatta and Badin and the talukas (sub-districts) of Ghorabari, Keti Bandar, Jati, Shah Bandar, Kharo Chan and Mirpur Sakro, Badin and SF Rahu.

(i). Scope of Services / Terms of Reference:

1. To find change in the project area, mangroves habitat and the general trends in the event of any disaster (flood, cyclone, sea intrusion)
2. Development of climatic data layers
3. Development of historic data layers
4. Historic disasters data layers with spatial extent, intensity and frequency
5. Development of soil data layers
6. Development of a suitable model to estimate the ecosystem health and extract the potential hazard areas
7. Perform an approximately forty years change trend analysis by using medium resolution satellite images i.e. Landsat, ASTER, SPOT etc.
8. Estimation of land erosion and accretion along the Indus delta
9. Identify the land use / land cover change trends of major land forms
10. Development of a prediction model
11. Stakeholders consultation during the project

(ii). Cost: Rs. 6.5 million

(iii). Project Period: Six months



6. Evaluation Criteria:

- (i) Applications with required documents attached shall be evaluated on the score obtained and firms obtaining 60% and above score shall be short listed / qualified.
- (ii) Firms / Organizations if found to have indulged in any corrupt or fraudulent practices or campaigning will have their applications not taken up for consideration.

The EOI can be submitted along with the following documents on the address herein on or before 4:00 p.m. on May 10, 2012. Request for Proposal (RFP) shall be issued to short listed consultants only.

5. Required Documents: It must include following details / documents:-

(A) Management Competence: 5 Marks (One mark for each year)

- (i) Name, address, telephone, fax numbers and email address of firm;
- (ii) Ownership and Organizational Structure of the firm
- (iii) Year of establishment

(B) Experience and past performance: 60 Marks

- (i) List of similar assignments with cost, under taken where the firm was in the lead partner
- (ii) List of assignments executed in similar geographical condition;
- (iii) List of similar assignments with cost, under taken where the firm was the sub-consultant
- (iv) Firm's specialization vis a vis the sectoral focus of the assignment
- (v) Firm's experience vis a vis the assignment's TORs

- (ii) Permanent / local office

(D) Key Personnel Qualification and Experience: 20 Marks

- (a) Academic Qualification:** Minimum Masters degree (5 marks, additional marking MPhil = 2, PhD = 3)
- (b) Experience:** Number of similar assignments with length of experience (2 marks for each similar assignment)

(E) Financial: 5 Marks (2 marks per year)

- (i) Documentary evidence of financial position, bank statement or audited accounts of the last two years.
- (ii) Annual turnover of the last two years
- (iii) Annual turnover should be double the amount of quoted price
- (iv) Income tax return for the last two years
