

Bid shall be valid for a period of 35 days after Bid opening and must be accompanied by bid security of 3% in the shape of call deposit in the name of Executive Engineer Education Works Division Matiari from any schedule Bank of Pakistan at the time of receiving of tenders on 22.05.2012 at 2:00 pm which will be opened on the same day at 3:00 pm in the presence of tender opening / evaluation committee and the bidders or their authorized representative who wish to be present.



- All bidders shall be required to submit their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
- 6. Bids are required to the submitted and provide a total price. Non compliance may result in rejection of bid.
- 7. Bidders should give their best and final price in their bids.
- As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
- The Competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules 2012.
- 10. If any of the information furnished by the Contractor / firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other action, legal and otherwise, will be taken against the contractor / firm.
