INVITATION FOR BIDS

1- The Enhanced HIV/AIDS Control Program is a leading public health program in Sindh and is providing HIV/AIDS & STIs treatment, OIs medicines, VCT (voluntarily counseling & testing) behavior change communication, harm reduction and awareness services to general population as well as vulnerable groups.

2- The Enhanced HIV/AIDS Control Program, Health Department, Government of Sindh invites sealed bids from eligible bidders for the following packages.

- i) Procurement of Medicines for STIs & Opportunistic Infections
- ii) Procurement of Testing Kits for HIV, HBV, HCV, Syphilis and Pneumococcal Vaccine
- iii) Printing of Information, Education & Communication (IEC) material
- iv) Procurement of Stationary & Miscellaneous items.
- v) Development of short & long video tele/documentary messages on issues related to HIV/AIDS.

3- The interested bidders may obtain further information and Data Sheet from May 14, 2012 on submission of written application from the address given below from 09.00hrs to 17.00 hrs and upon payment of a nonrefundable fee of Pak Rupees 1000/= (One Thousand Only) in cash/bank draft/pay order in favour of the Enhanced HIV/AIDS Control Program for each package.

4- a) For the item Nos. i) ii) iii) & iv) the bidders are required to submit 05 copies of Financial Proposals as per details/specification given in data sheet, following single stage one envelope procedure.

b) For item No. v) the bidders are hereby required to submit 05 copies of both technical & financial proposal, as per details/specification given in data sheet, following single stage two envelopes procedure.

5- The bidders are requested to give their best and final prices as no negotiations are allowed.

6- The bidders will be selected in accordance with the procedures set out in of SPPRA Act 2009, and Sindh Public Procurement Rules 2010.

7- The Proposals should reach the address given below on 30th May 2012 by 01:00 pm and must be accompanied by 2% Bid security in shape of Pay Order or Bank Draft in the name of Enhanced HIV/AIDS Control Program Sindh.

8- Bids will be opened in the presence of bidders or their authorized representatives on 30th May 2012 at 02:00 pm in the office of the Provincial Program Manager, Enhanced HIV/AIDS Control Program, Karachi.

9- As provided in the Bidding Documents, bidder(s) engaged in corrupt or fraudulent practices (including collusion/ polling) will be declared ineligible either indefinitely or for a stated period of time by the purchaser.

10- The purchaser reserves the right to accept or reject any/all bid(s) without assigning any reason to the bidder(s) as per provision of Sindh Public Procurement Rules 2010.
