

2. Tenders in sealed cover should be submitted in the above cited office by 2.30 P.M on 4<sup>th</sup> June, 2012. Tenders shall be opened on the same day at 3.30 P.M in the presence of bidders or their authorized representatives who care to be present.
3. Earnest Money / Bid Security @5% of the total value of offered bid in shape of Pay Order of any scheduled Bank should be submitted alongwith the bid.
4. Rates should be quoted on FOR Karachi basis.
5. Cutting or overwriting in the tender must be avoided.
6. Tenders received after specified time and date will not be considered.
7. Conditional tenders and those without earnest money shall not be entertained.
8. Validity of tender shall remain for 60 days from the date of opening of tender.
9. Sales Tax Registration / NTN must be mentioned on the tender documents.
