

1. Tender documents are available for sale on written application, during working hours from Youth Affairs Department, Govt. of Sindh, 3rd Floor, Room No. 454, Karachi on any working day on payment of Rs.500/- non-refundable cost of tender. No tender will be sold on tender opening date.
2. Tenders in sealed cover should be submitted in the above cited office by 2.30 p.m on 1st June, 2012. Tenders shall be opened on the same day at 3.30 p.m in the presence of bidders or their authorized representatives who care to be present.
3. Earnest Money / Bid Security @5% of the total value of offered bid in shape of Pay Order of any scheduled Bank should be submitted alongwith the bid.
4. Rates should be quoted on FOR Karachi basis.
5. Cutting or overwriting in the tender must be avoided.
6. Tenders received after specified time and date will not be considered.
7. Conditional tenders and those without earnest money shall not be entertained.
8. Validity of tender shall remain for 60 days from the date of opening of tender.
9. Sales Tax Registration / NTN must be mentioned on the tender documents.
10. Necessary warranty / guarantee is essentially required.
11. Inspection will be made by the buyer prior to delivery.
12. An affidavit to the effect that the firm / contractor is not blacklisted by any executing agency should be enclosed with the bid.
13. Earnest money of unsuccessful bidders shall be retained till finalization of the case.
14. In case the date of opening is declared public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
15. Boucher / literature must be enclosed with the bid where necessary.
16. The competent authority reserves right to increase or decrease quantity of any item.
17. The delivery of goods / items shall be made by the successful bidder within 10 days positively.
