Bids shall be valid for a period of 35 days after bid opening and must be accompanied by bid security of 3% in the shape of call deposit in the name of Executive Engineer Education Works Naushahro Feroze from any scheduled Bank of Pakistan at the time of receiving and opening of bids on the dates mentioned as under at office of the Executive Engineer Education Works N.Feroze @ 2:00 pm in the presence of Bid Opening / Evaluation Committee comprising Deputy Commissioner Naushahro Feroze, Superintending Engineer (W&S) Department N.Feroze, Executive Engineer, Education Works Naushahro Feroze & Divisional Accounts officer of this office & the bidders or their authorized representatives who wish to be present.

5. All bidders are required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidders is qualified to perform the work.
6. Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (In Rupees) must be filled by the bidders for each item in the bill of Quantities and provide a total price. Non-compliance may result in rejection of bid.
7. In case of dispute, dispute resolution mechanism will be as per SPPRA rules 2010.
8. As provided in the bidding documents, bidders engaged corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
9. Bids will be issued to bidders who possess ten years experience in the building works such certificate of Works & Services Department is required to be attached with the application of bidders.
10. Applications demanding for tenders must be supported with the complete profile of technical works executed previously and financial documents for scrutiny.
11. The competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules, 2010.
12. For any other requirement, please refer bid document.
13. If any of the information furnished by the bidder/contractor / firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other actions, legal and otherwise, will be taken against the contractor / firm.
