

TENDER NOTICE **(FOR PUBLICATION)**

FOR THE PROCUREMENT OF HELICOPTER ON CHARTER FOR 12 MONTHS

1. Government of Sindh (GoS) invites sealed technical and financial bids in separate envelopes under single stage two envelop procedure of SPPRA 2010 Procurement Rules from national / local firms having a minimum operating experience of 3 years in Pakistan, alongwith an AOC issued by the CAA Pakistan, for rental services of 1 Helicopter and 1 Back Up Helicopter for a period of 12 months as per following terms and conditions:-

Terms & Conditions

- a. The duration of charter period will be 12 months from the specified start date in the agreement, which may be further extended with mutual consent.
- b. Flight hours. A minimum of 300 guaranteed hours per year. A contract for 12 months for a cumulative total of 300 hours per annum will be signed. However, payment for any additional hours flown will be made at the same rate per hour.
- c. The Government of Sindh, shall only be responsible for flying charges. All operational, maintenance and administration cost shall be borne by bidder.
- d. The bidding firms must qualify as per Government financial rules and mention their NTN & Sales Tax Registration number.
- e. Bid security (refundable) @ one percent (1%) of the bid value in the shape of Pay Order in the name of Secretary (GA), Services, General Administration & Coordination Department, GoS. Bids without Bid Security will not be entertained. Successful bidders will be required to sign a detailed contract with Government of Sindh and furnish performance guarantee in the name of Secretary (GA), Services, General Administration & Coordination Department, GoS, equal to 5% of bid value till the completion of charter period.
- f. Bidders may obtain any clarification regarding flight operation from the office designated by GoS, on as and when required basis.
- g. Payment Schedule :-
 - i) Rental charges would be paid monthly by 7th of each month.
 - ii) Any hours flown beyond 300 hours will be paid within two to three weeks of invoicing.
- h. The price must be quoted in Pak Rupees in figures & words. The quotes must be inclusive of all duties / taxes / levies related expenses as presented by the Government of Pakistan and Government of Sindh from time to time and must be valid for a period of three (03) months from the date of quote.
- i. Payment will be in Pak Rupees through Bank Draft as per SPPRA Rules, 2010.
- j. Awarding of contract shall be subject to clearance of the Helicopter by a committee of professionals to be constituted later by the Government of Sindh.
- K. The bidding firm is required to submit their bids in line with the SPPRA Rules, 2010.
