- Blank tender documents can be obtained from the office of the undersigned on payment of cost of tender documents (not refundable) as mentioned in the list from the date of publication till 13.06.2012. The same will be received back in sealed cover on 14.06.2012 up to 12.0 noon and will be opened by the Tender Opening Committee on same day at 2.00 (PM) in presence of the intending contractors or their authorized representative who may like to be present.
- The tender documents should accompany the 2% bid security of the estimated cost of works in the shape of pay order or call deposit from any of the scheduled Bank duly pledged to the undersigned.
- The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. incomplete/ conditional tenders will not be accepted. In addition the bidders must be furnished documentary evidence against each eligibility criteria as mentioned above. other wise their tender will be summarily rejected without consideration.
- The tender can be downloading from SPPRA's website.
- In case the date of opening declared as a Public holiday by the Government or non working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
- The procuring agency may reject all or any bids or proposals at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA rule 2010.
- In case of firm being partners/ partnership deed, given full particulars of Director/ Proprietors or other connected along with power of attorney. In case of being whole proprietor such under taking on affidavit is furnished.
- Affidavit to the effect that the firm is not involved in any court case and that no work has been left by the firm incomplete.
- Documentary evidence regarding under completion/ completed works along with satisfactory completion certificate from the concerned department.
- An affidavit to the effect that the firm/ contractor are not blacklisted by any executing agency should be enclosed with the bid.
- Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who report canvassing will liable for rejection.
- Tenders will not be received after the schedule time.
