1 The Provincial Government has received a loan / grant / funds from the Donors / Government to be applied towards the Rehabilitation of School works (Construction of Shelterless Primary Schools & Missing Facilities, Additional Class Rooms, Structural Repair) and intends to apply the funds to cover eligible payments under the contract for Taluka Based Projects in District Tando Allahyar, Bidding is open to all bidders from eligible source as defined in Part-1 (fixed) of the Bidding Documents through National Competitive Bidding: Procurements of Works - Smaller Contracts containing the Conditions of Contract.

Interested bidders may obtain further information at the same address.
- 4 Bid shall be valid for a period of 35 days after bid opening and must be accompanied by Bid Security of 3% in shape of Call Deposit in the name of the Executive Engineer Education Works Division Tando Allahyar from any Schedule Bank of Pakistan at the time of receiving of tenders on **15-06-2012 @ 2:00 P.M** which will be opened on the same day at 3:00 P.M in the presence of Tender opening / evaluation committee and the bidders or their authorized representative who wish to be present.
- 5 All bidder shall be required to submit with this bid, qualification information specified in the bid documents. This information shall be used to establish through post qualification whether the bidder is qualified to perform the work.
- 6 Bids are required to be submitted on item rate basis, Rates and amounts must be filled by bidder in Pak Rupees for each item in the bill of quantities and provide a total price. Non compliance may result in rejection of bid.
- 7 Bidders should give their best and final price in their bids.
- 8 As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
- 9 The Competent authority reserves the right to reject any or all bids subject to relevant provision of SPPRA Rules 2010.
- 10 If any of the information furnished by the contractor / firms proves to be false at any stage, the contract, even if awarded, it liable for cancellation and other action, legal and otherwise, will be taken against the contractor / firms.
- 11 In case of any dispute regarding any step or stage of contract, a detailed dispute resolution mechanism is given in SBD and as per SPPRA Rules 2010.
- 12 For any other requirements please refer bid documents.
- 13 If any tender remains un responded the next date of issuance, receiving back / opening shall be as follows.
