- (1) **1st Envelope should contain Technical proposal only (for each group in a single Technical Bid) and be clearly marked "Technical Proposal".**
- (2) **2nd Envelope should contain Financial Proposal" (Rates Item wise)(separate envelope for each quoted item) alongwith earnest money @ 2 percent of the quoted rates in the shape of pay order / demand draft in favour of EDO Health CDGK Defunct (refundable to unsuccessful bidders) the envelope be clearly marked as "Financial Proposal".**

CLARIFICATION:-

The rate of each item should be quoted separately and alongwith earnest money be sealed in a separate envelope and labeled as **FINANCIAL PROPOSAL** Name of item and name of the firms/company be written in bold letter on the envelope otherwise it may not be entertained.

- (3) **Both envelope (Technical and Financial) should be sealed separately and placed in a 3rd Envelope. The name of the bidder be clearly marked on all envelopes.**

Tender should be dropped in the tender box kept in the office of the EDO (Health) CDGK (Defunct) @ 6th Floor Civic Center, Karachi **on above said date & time.**

The Technical Proposals of bids shall be opened publicly on **above said date & time** in presence of bidders or their nominated representatives who wish to attend.

After the evaluation and approval of the technical proposals for Purchase of Equipments/ Instruments/ Machinery/ Furniture & etc on the basis of **Documents/original Brochures etc**, the authority shall publicly open the **financial proposals of the technically accepted bids** only in the office of the EDO (Health) CDGK (Defunct) @ 6th Floor Civic Center, Karachi. **The financial proposal of bids found technically non-responsive shall be returned un-opened to the representative bidders.**
