Bid shall be valid for a period of 35 days after Bid opening and must be accompanied by bid security of 3 % in the shape of call deposit in the name of Executive Engineer, Education Works (Works & Services) Khairpur from any schedule bank of Pakistan at the time of receiving and opening of bids upto 27-06-2012 during office hours and will be received on next day i.e 28-06-2012 at 2:00 pm and will be opened at 3:00 pm in the presence of bid opening / evaluation committee comprising Deputy Commissioner Khairpur as Chairman, Superintending Engineer Works & Services as Member, Divisional Accounts Officer and the under signed as a Member, and the bidders / persons or their authorized representatives who wish to be present.
5. All bidders are required to submit with their bids, qualification information specifies in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
6. Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidders for each item in the bill of quantities and provide a total price. Non compliance may result in rejection of bid.
7. In case of dispute, dispute resolution mechanism will be as per SPPRA rules 2010.
8. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
