The contractor shall have to attached the 2% Earnest money for total bid (refundable after finalization of tenders) in shape of pay order of any schedule bank drawn in favour of K.M.C with the tender documents failing which the offer will be treated as cancelled.

The contractor will drop short tender documents in the short tender box affixed in the office of the Director General, Parks and Horticulture Department, Karachi Metropolitan Corporation inside Bagh-e-Jinnah (Frere Hall) Fatima Jinnah Road, Karachi on date of opening dated 08 / 06 / 2012 upto 2.30 P.M. and quotation will be opened in the presence of those contractors who wish to be present.
