- Bidding documents (and additional copies) may be purchased from office of the Executive Engineer, Education Works Division. Behind Govt. Boys Degree College, Tando Muhammad Khan on any working day on payment of Rupees 1000/- for a non-refundable tender fee. Interested bidders may obtain further information at the same address.
- All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work. Rates and amounts must be filled by bidder in Pak Rupees for each item in bill of quantities and provide a total price. Noncompliance may result in rejection of bid. Bid shall be valid for a period of 35 days. Bid Security is 3% of the quoted price. Bidders should give their best and final price in their bids as there will be no negotiations. The bids will be opened in the presence of bid evaluation committee and the bidders of their authorized representative who wish to be present.
- The Competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules, 2010.
- If any of the information furnished by the contractor / firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other actions, legal and otherwise, will be taken against the contractor / firm.
- As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
- In case of any dispute regarding any step or stage of contract, a detailed dispute resolution mechanism is given in SBD and as per SPPRA Rules 2010..
- Tenders will be issued to the bidders who possess Ten (10) years experience in buildings works such certificate of Works & Services Department is required to be attached with the application of bidders.
- Application demanding for tenders must be supported with the complete profile of Technical Works executed previously and financial documents for scrutiny.
- The approved tenders will be subject to stamp duty levied by the Government.
- For any other requirement please refer bid document.
