TERMS & CONDITIONS:

1. The Tender Documents will be issued to the party (ies) on written request, duly supported with latest copy of Income Tax /Sales Tax Certificate alongwith cost of tender (in shape of pay order) from any scheduled bank in favour of KMC.
2. In case, the tender is not responded to on the due date for any reason, the next date of submission and opening will be 29-6-2012. The tender documents will also be available for sale upto 29-6-2012.
3. In case the opening date is declared as Public Holiday by the Government, the tender will be opened on the next working day. The other terms and conditions shall, however, remain unchanged.
4. 2% Earnest Money /Call Deposit (in shape of pay order) of the total bid amount must be accompanied with the tender, which shall be retained till expiry of the validity of bid / finalization of the case, which ever comes earlier.
5. Any Canvassing in connection with tenders is strictly prohibited.

6. The total bid amount as well as the rates of items must be clearly filled in (both in figures and in words). In case of any correction/over writing, the same must be initialed by the contractor, else the tenders will be summarily rejected.
