Procurement & Installation of UF / Nano / RO Treatment Plants in ALL DISTRICT OF Sindh

The Government of Sindh intend to provide safe source of potable water on regular basis to the villages in all district of Sindh Province by establishing Drinking Water Hub as a centralized source for village / cluster of villages. It is intended that part of the allocated amount for the project "Drinking Water Hub" Phase-II will be applied to eligible payments under the contract for the subject Project.

Scope of Work:

Design, supply, install, commission, operate and maintain Seven hundred and fifty number (750) of water treatment plant based on UF / Nano / RO technology, as per site condition to be installed at various sites in all Districts of the Province of the Sindh under the phase-II of the Project DWH. The capacity of each plant will be minimum 15000 gallons per day based on 18 hours daily operation along with one year defect liability period plus three years Operation & Maintenance services and four years International comprehensive warranty. The completion period is six (06) months for the job.

As specified in SPPRA rules 46(2) Bid shall comprise a single package containing two separate envelops marked as "Financial Proposal" and "Technical Proposal" in bold and legible letters to avoid confusion. The Technical Proposal found technically qualified under evaluation/ marking criteria given in bidding document would only be considered for opening of Financial Proposal.

The bidding is open to all firms that is local manufacturer, authorized representatives of international manufacturer and engineering firms who are meeting the following criteria.

1. Valid Registration with Pakistan Engineering Council in Category C-3 or above necessarily having specialization in CE-09, CE-10 and ME-06 in relevant

2. List of Engineer working with the bidder along with the registration with Pakistan Engineering Council.

3. Registration with Tax authorities

Last three year audited financial statement.

5. Latest certificate from the bank confirming that the company has strong financial strength to undertake and complete the subject project within stipulated time frame.

6. Proven track record for completion and operation of similar type of project in Pakistan (Certificate from the employer for satisfactory completion and

operation must be required).

Certificate confirming that the bidder never black listed from any Govt.

8. Distribution Agreement (s) / JV Agreement (s) and technical association with the international manufacturer /OEM.

9. Address of regional offices (if any in Sindh Province)

 Technical association / sales distribution / JV arrangement with International manufacturer of water filtration equipment.

The Project Director will not be responsible for any delay in postage.
