Executive Engineer Education Works Division Ghotki & Divisional Account Officer of this office & the bidders are their authorized representatives who wish to present.
5. All bidders shall be required to submit with their bids. Qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidders is qualification to perform the work.
6. Bids are required to be submitted on the item rate base (Not on the bases of the composite schedule of rates with percentage premium) and the rates the amount (In rupees.) must be filled by bidders for each item in the bill of quantities and provided total price. Non-compliance may result in rejection of bid.
7. In case of dispute, dispute resolution, mechanism will be as per SPPRA rules 2010.
8. AS provided in the bidding documents, bidders engaged corrupt or fraudulent practices (Including collusion / pooling) will be declared ineligible. either indefinitely or for a stated period of time to be awarded a contract funded by the Government.
9. Tenders will be issued to bidders who possess ten years experience in building works such certificate of Works & Services Department is required to be attached with the application of bidders.
10. Applications demanding for tenders must be supported with the complete profile or technical works executed previously and financial documents for scrutiny.
11. The Competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules 2010.
12. For any other requirement please refer bid document of bidders.
13. If any of the information furnished by the contractor / firm proves to be false at any stage. The contract even if awarded is liable for cancellation and other actions. Legal and other wise will be taken against the contractor / firm.
