Sealed Tenders are invited from the interested bidders meeting the eligibility criteria of "Sindh Public Procurement Regulatory Authority (SPPRA) Rules 2010 for ADP scheme No. 1930 (2012-13) i-e. "Expansion and Improvement of DHQ Hospitals in Sindh", for Construction of Allied Buildings, External Development & External Services & Renovation works in DHQ Hospitals at BADIN & SHIKARPUR

- The last date for receipt of Tender is 3<sup>rd</sup> August, 2012 up to 14:00 Noon and will be opened on same day at 14:30 PM in the presence of tender opening / evaluation committee and the bidders or their authorized representatives who wish to be present.
- If due to unavoidable circumstances, the undersigned is out of Headquarter, or in case
  of public holiday declared by Government, the tender shall be opened on next working
  day.
- 4. Eligibility conditions for intending participants are as under:
  - a. Full name of the firm along with organizational structure and permanent address with telephone number, fax number and e-mail.
  - b. Details of works executed by the contractors in the past five (05) years indicating scope of works, estimated cost and time taken for completion duly certified by the concerned officials.
  - c. List and location of equipments, transport and machinery available with the contractor for this job.
  - d. Affidavit that the contractor has neither been black listed by any agency nor involved in any subversive activities.
  - e. Copy of valid enlistment letter of Pakistan Engineering Council in between C-III to C-IV category.
  - Bio-data of the technical staff permanently employed and available with the firm/contractor.
  - g. List of cases entered into arbitration/Litigation. If not involved then affidavit to the effect that the firm /Contractor was not involved in any litigation, no work was rescinded in the past:
  - h. List of works where penalty is involved, if any.
  - i. Income tax returns of last three years duly certified / verified.
  - Any additional information the applicant may like to furnish in support of its papers.

- 5. The earnest money specified should be in the name of Project Director "Rehab: of DHQ and THQ Hospitals in Sindh" in the shape of call deposit / pay order i.e. 3% of bid price quoted, from any scheduled bank and must be attached with sealed bid documents, otherwise it will not be entertained.
- If firm / partner is involved in partnership deed, then complete details / instructions and power of attorney be submitted with affidavit by the proprietor.
- Conditional and Telegraphic tender will not be entertained.
- The competent authority reserves the right to reject any or all tenders/ bid proposals, subject to the relevant provisions of SPPRA rules 2010.
- The bidding will be one stage-two envelope procedure i.e. Technical Proposal and Financial Proposal marked separately duly sealed in single package.

Works will be carried out as per the specifications contained in the lender documents.
