- 4. The last date of submission of sealed tenders in the Directorate of Urban Policy & Strategic Planning, Sindh, Planning & Development, Department, Govt. of Sindh, Bungalow No. D-45, Clifton Block-I, KDA Scheme No. 05, Karachi shall be 27<sup>th</sup> August, 2012 up to 1:00 PM and the tenders will be opened on the same day at 3:00 P.M in presence of the Procurement Committee (Goods), in the Directorate of Urban Policy & Strategic Planning, Sindh, P&D Department, Govt. of Sindh, Karachi and in presence of the Contractors or their authorized agents present at the time.
- If the Chairman, Procurement Committee or any member of the committee happens to be out of the Head quarter on the date of opening of tenders the same will be opened on the next working day at 1:00 P.M.
- The competent authority reserves the right to reject any or all the Tenders without assigning any reason thereof.
- 7. Eligibility conditions for intending participants are as under:
  - a) All firms must be authorized dealers / gold partners of HP/Dell/IBM etc and provide valid certificate
  - b) Bidders must be registered with Income tax and sales tax.
  - c) Minimum 5 years of relevant experience.
  - d) Turn-over of last three years be more than 20 million.
  - e) Liquid assets be at least three (3) times the amount of bid.
  - f) Documentary evidence of similar works executed / works in progress and certificate of satisfactory completion of works by the employers, particularly same nature of works.
- 8. Registration with Income Tax Department (NTN certificate) with sales tax Authorities.
- Under Taking on Affidavit that Firm is not involved in any litigation or abandoned any work in the Department.
- Affidavit to the effect that the Firm / Contractor have not been black listed previously by any
  executing agency.
- 11. Affidavit to the effect that all documents / particulars / information furnished are true correct.
- 12. In case of Firm, list of partners / Partnership Deed, giving full particulars of Directors / proprietors or others connected along with Power of Attorney. In case of being sole proprietors such undertaking on Affidavit be furnished.
- 13. Technical and Financial Proposals should be submitted in separate envelopes and both should be sealed in third envelope. Only Technical Proposal shall be opened in presence of Tenderers on the tender opening date and time.
