The Education & Literacy Department now invites sealed bids on Single stage two envelope procedure from eligible bidders to procure Interactive Learning Solution (ILS) for Science Classrooms at various colleges of Sindh Province on turnkey basis. Bids are requested from well reputed firms dealing in Interactive Learning Solutions (ILS), having office in Pakistan, preferably in province of Sindh, and who can deliver ILS on Turn Key Basis. - 6. Bids will be opened by the purchase committee of the Department in the presence of bidders' / representatives of bidders on 22-10-2012 at 3.30 pm at the committee room of Education & Literacy Department 1st Floor Tughlaq House, Sindh Secretariat No.02, Kamal Atta Turk Road, Karachi.
- 7. The rates quoted should be inclusive of GST, Income Tax, etc GST will be deducted at source as prescribed rates. Delivery of items will be made institution wise as mentioned in bidding document.
- 8. The bidders are requested to give their best and final prices as no negotiations are expected.

- 9. In case Government declared / announce public holiday on the date of opening of Tender, the Tenders will be opened on the next working day.
