- Bids shall be valid for a period of 35 days after bid opening and must be accompanied by bid security of 3% in shape of call deposit in the name of Executive Engineer, Education Works Division, Matiari from any schedule bank of Pakistan at the time of receiving of tenders on **19.12.2012 @ 2:00 pm** which will be opened on the same day at **3:00 pm** in the presence of Bid Opening / Evaluation Committee and the bidders or their authorized representatives who wish to be present.
- All bidders are required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidders are qualified to perform the work.
- Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidders for each item in the Bill of Quantities and provide a total price. Non-compliance may result in rejection of bid.
- Bidders should give their best and final price in their bids.
- As providing in the bidding documents, bidders who engage in corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
