The Executive Engineer Education Works near Government Boys Pilot Secondary High School Dadu has received a loan/credit/fund for the Donor/Government to be applied towards the Rehabilitation of School Works (Construction of Shelter-less Primary School/Up-gradation/Provision of lacking Facilities Addition Class Rooms of Electric Work) and intends to apply the funds to cover eligible source countries as defined in Part One (Fixed) of the Bidding Documents, for National Competitive Bidding Procurement of Works-Smaller Contracts containing the conditions of Contract.

Interested bidders may obtain further information at the same address.

4. Bids shall be valid for a period of 35 days after Bid opening and must be accompanied by bid security of 3% in the shape of call deposit in the name of Executive Engineer Education Works Dadu from any Scheduled Bank of Pakistan at the time of receiving and opening of tenders on the date mentioned as under Executive Engineer Education Works Division Dadu near Government Boys Pilot Secondary High School Dadu at 1:00 pm in the presence of tender opening / evaluation committee and the bidders of their authorized representative who wish to be present.
5. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to established through post-qualification whether the bidder is qualified to perform the work.
6. Bids are required to be submitted on item rate basis (not on the basis of composite schedule of rates with percentage premium) and the rates and amount (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Non compliance may result in rejection of bid.
7. In case of any dispute regarding any step or stage of contract, a detailed dispute resolution mechanism will be as per SPPRA rules 2010.
8. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/ pooling) will be declared ineligible, either in indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
9. Application demanding for tenders must be supported with the complete profile to technical works executed previously and financial demand of scrutiny.
10. The competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules 2010.
11. For any other requirement please refer bid documents.
12. If any of the information furnished by the contractor/ firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other actions, legal and otherwise, will be taken against the contractor/ firm.

Bidders should give their best and final price in their bids as no negotiations are expected.
