Procurement of Cancer Medicines

- After the successful implementation of program for free treatment of blood cancer patients by the Government of Khyber Pakhtunkhwa, the Provincial Government, through the Health Department, has initiated project under the scheme "Begum Nusrat Bhutto Oncology Services" for cancer patients in the Province. Under the scheme, free treatment with quality medicines will be provided to all cancer patients of the Province considering the hardships faced by them due to extremely high cost of cancer medicines.
- The Health Department, Government of Khyber Pakhtunkhwa, invites sealed bids from eligible bidders (manufacturers or authorized importers) to procure cancer medicines on the prescribed Standard Bidding Documents through post-qualification.

An undertaking to the effect that the requisite Bid security has been attached with the Financial bid, has to be provided along with the Technical bid.
