- 2- The Enhanced HIV/AIDS Control Program Sindh has extensive network of Preventive and /curative Services like 12 Service Delivery Packages (for Injecting Drug Users, Male Sex Workers, Female Sex Workers, Truckers, Jail Inmates and Street Children MARA), 05 HIV/AIDS Treatment & Care Center, 03 PPTCT (Prevention of Parent to child Transmission) Sites, 21 VCCT (Voluntarily Counseling & Confidential testing) Centers and 46 STIs (sexually transmitted Infections) Clinics.
- 3- The above mentioned services are being provided free of cost to vulnerable groups and general population throughout sindh at teaching & district headquarter hospitals level.
- 4- In this PC-1, Small grants scheme has been designed to provide limited funding for interventions/ research/ approaches and to facilitate investigation and analysis of emergent problems related to HIV/AIDS and Strengthening network and providing support to people living with HIV/AIDS. These resources are primarily intended to enhance public – private partnerships to enable reduction in infections
- 5- Enhanced HIV/AIDS Control Program invites eligible Consulting Firms/ NGOs/Organizations/Institutions (hereafter referred to as Consultants) to submit Expression of Interest to work with Vulnerable Population for preventing and controlling of HIV/AIDS and STIs.
