NOTICE INVITING TENDER FOR PRE-QUALIFICATION OF CONTRACTORS

CONSTRUCTION OF WATER CARRIER FROM NABISAR RESERVOIR TO THAR COAL FIELD BLOCK-II

- Government of Sindh, Coal & Energy Development Department through Sindh Coal Authority (SCA) intends to utilize the portion of ADB for the project / schemes cited above with scope, tentative cost estimates and other details as under:-

Scope: The Government of Sindh Coal & Energy Development Department is taking steps to provide enabling infrastructure to generate power/energy from the Coal, which is a natural gift available in mass quantity in the desert area of the Tharparkar District in the Province of Sindh. To meet the requirement of power generation water is a prime requirement. The Government of Sindh through Sindh Irrigation & Drainage Authority (SIDA) is endeavoring to supply water through available irrigation network upto Nabisar Reservoir. The supply of water from Nabisar Reservoir to Thar Coal Field Block-2 to be used for power generation is the responsibility of Sindh Coal Authority (SCA). The Government of Sindh, Coal Energy Development Department through Sindh Coal Authority (SCA) has therefore decided to carryout project being the infrastructure development essentially required to initiate mining and ultimately power generation activities in Thar Coal Field.

In First Phase the scheme shall be developed for supply of 35 cusecs of water from Nabisar Reservoir to Thar Coal Field Block-2. The amount of water is required for production of 1,000~1,200 MW of electricity on the basis of roughly calculated demand of 3~4 cusec for 100 MW power generation is first stage which shall be enhanced in future accordingly to meet the requirement of future power generation.

- (i) **Estimated Cost:** Pak Rs. 4,078.270 million approximately
No. of Contract Packages 5 - 6
Value of Contract Packages Pak Rs.700 to 1000 million
- (ii) **Project Completion Period:** 15 months (448 days approximately)
- (iii) **Bidding Process:** National Competitive Bidding (NCB)

- **Eligibility:** Valid Registration with relevant tax authorities and Pakistan Engineering Council in C-1 category in construction of water supply transmission mains/water conveyance system, storage reservoir etc. in CE04 & CE09 is mandatory.
