





Expression of Interest for Female Youth Health Counselor

Youth Affairs Department, Government of Sindh in collaboration with the Habib University Foundation (H.U.F.), has initiated a project titled "YES" - "Youth Empowering Spaces" - an innovative youth development framework aspiring to create inspiring learning and growing spaces and to provide youth with opportunities to become personally, socially and economically empowered. YES recognizes empowerment as a multidimensional process enabling youth to gain personal power and confidence to manage and improve their own lives and the lives of their families and communities in a conscious, proactive and self-controlled way. YES program is being implemented in Karachi, Jamshoro and Matiari.

Scope of the Services Required

One of the core themes of YES project is related to Awareness and Guidance. Under this theme, seminars and one-on-one guidance is provided to youth for their mental, emotional and physical wellbeing as well as how they can plan their careers based on their interests and aptitude.

Services of a Female Youth Health Counselor are required to undertake the following tasks:

- In collaboration with YES Team, develop and implement a plan for the one-on-one health specially psychosocial health guidance for female youth of Karachi and Matiari.
- 2. Develop tools to record the data of participants and the guidance process

- Analyze the data and develop small report on critical issues and concerns faced by young females vis-à-vis their social and psychosocial health
- 4. Identify common issues and conduct small group discussions and seminars for female youth in Karachi and Matiari.
- 5. Identify organizations or individuals through which youth can get more advice and support.

Duration

The duration of service will be from Mid-January/February 2013 to June 2013. The timings would be from 10.00 a.m. to 6.00 p.m. from Monday to Saturday. Timings may vary to some extent depending upon the response of females. Services will be required at the Institute of Advancing Careers and Talents, Malir where this initiative housed and in Matiari
