

NOTICE INVITING TENDERS.

- 1 The Executive Engineer, Education Works Division, Mirpurkhas Near Governemnt Boys High School (Hostel Building) Mirpurkhas has received a loan/grant/credit/fund from Donor/Government to be applied towards the Rehabilitation of school works (Construction of Shelterless Primary Schools and missing facilities, Addition Class Rooms) and intends to apply the funds to cover eligible payments under the Contract for Taluka based projects. Bidding is open to all bidders from eligible source as defined in Part One (FIXED) of the Bidding Documents For National Competitive Bidding: Procurement of Works-Small Contractors containing the Conditions of Contract.
- 2 The Executive Engineer, Education Works Division, Near Governemnt Boys High School (Hostel Building) Mirpurkhas under Sindh Education Refrom Programme (SERP) ToP-IV, Government Of Sindh invites sealed bids from eligible bidders for following works.

- 3 Bidding documents (and additional copies) may be purchased from the office of Executive Engineer, Education works Division, Near Government Boys High School (Hostel Building) Mirpurkhas for non-refundable fee of Rs.1,000/- in favour of District Government (or Departments account should be mentioned) for each set. Interested bidders may obtain further information at the same address.
- 4 Bids shall be valid for a period of 35 days after Bid opening and must be accompanied by bid security of 3% in the shap of call deposit in the name of Executive Engineer, Education Works Division, Mirpurkhas from any scheduled Bank of Pakistan at the time of receiving and opening of tenders on the date mentioned as under at office of Executive Engineer, Education Works Division, Mirpurkhas at 1:00 pm in the presence of Tender Opening/Evaluation committee Mirpurkhas & the bidders or their authorized representative who wish to be present.
- 5 All Bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
- 6 Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Noncompliance may result in rejection of bid.

- 7 In case of dispute, dispute resolution mechanism will be as per SPPRA Rules.
- 8 As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
- 9 Tenders will be issued to bidders who possess ten years experience in the building works such certificate of Works & Services Department is required to be attached with the application of bidders.
- 10 Applications demanding for tenders must be supported with the complete profile of technical works executed previously and financial documents for scrutiny.
- 11 The Competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA rules 2010.
- 12 For any other requirement please refer bid document.
- 13 If any of the information furnished by the contractor/firm proves to be false at any stage, the contract, even if awarded is liable for cancellation and other actions, legal and otherwise, will be taken against the contractor/firm.
