Invitation of bids is invited from the eligible firms or persons for supply/testing and commissioning of 400 KVA PMT along with its accessories prequalified with KESC and registered/licensed by Pakistan Engineering Council in the appropriate category.

Supply/testing and commissioning of 400 KVA PMT along with its accessories and other allied works to the office measuring 13,000 sq.ft. (Under Turnkey basis).

Documents / Information: The interested firms are required to submit their applications with the following documents / information:

- a. Name of firm, address, telephone / fax no. and name of the focal personnel / Chief Executive.
- b. Proof of registration with PEC /PCATP for the year 2012.
- c. Details of similar works (with cost), completed during last 10 years with completion certificate.
- d. Details of similar works (with cost) for works in hand with proof (commencement order must be provided).
- e. List of tools, plants equipment machineries with evidence of ownership.
- f. List of qualified technical and non-technical personnel with their bio-data.
- g. Financial status with proof of last one year, bank statement and last three years' tax assessment/ balance sheet audited by chartered accountants.
- h. National Tax Number / Sales Tax Registration Number.
- i. Certificate to the effect that the firm is not involved in litigation with any Department (Government / Semi Government, Autonomous or other clients).
- j. An undertaking on stamp paper by the firm / contractor to the effect that "Neither the firm / contractor nor its directors / stakeholders, as a whole or part of the company / organization, have ever been blacklisted / defaulted with any government agency / department / organization and also that the information supplied by the firm / contractor is correct".

Method of Procurement: Single stage – Two envelopes. Under turnkey basis firms interested must send their Technical and Financial proposal in two separate sealed envelopes to the undersigned at the given address. All bids must be accompanied by bid security in amount of equal to 2% of bidding amount in form of pay order.

Technically qualified firms will be invited for financial proposal.


