2. The last date of receipt of tender is **3rd March 2013 up to 12:00 noon** which will be opened on **the same day at 2:00 pm** in the presence of Tender opening /Evaluation Committee and the bidder or their authorized representative who wish to be present.
3. Eligibility conditions for intending participants are as under :
  - a) Full name of the firm along with organizational structure and permanent address with telephone number, fax number and email.
  - b) Details of work executed by the contractors in the past ten years indicating scope of work, estimated cost and time taken for completion duly certified by the concerned authorities.
  - c) List and locations of equipments, transport machinery available with the contractor for this job.
  - d) Affidavit that the contractor has neither been black listed by any agency with the firm /contractor for this project.
  - e) Copy of fresh enlistment letter of Pakistan Engineering Council in C-3 / C-2 category & above only.
  - f) Bio data of the technical staff permanently employed and available with the firm /contractor for this project.
  - g) List of cases entered into arbitration /litigation. If not involved then affidavit to the effect that the firm /contractor was not involved in any litigation, no work was rescinded in the past.
  - h) List of work where penalty is involved, if any.
  - i) Income tax returns of last three years duly certified /verified.
  - j) Professional Tax Certificate.
  - k) Any additional information the applicant may like to furnish in support of his papers.
4. If firm /partner involves in partnership deed, then complete details /instructions and power of attorney will be submitted on stamp paper by the proprietor.
5. Conditioned and telegraphic tenders will not be entertained.
