- The provision in the instructions to bidders and in General Conditions of contract is the provision of the Sindh Public procurement ordinance and its rules made there under.

Bids must be delivered to the office of Director Plant Protection, Agriculture Extension Sindh Hyderabad on or before 11.03.2013 up to 11.00 am and must be accompanied by their bid containing two envelopes for technical and financial proposal separately. Each envelope must clearly be marked a "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letter to avoid confusion.
- Tenders / Bids are required to be furnished with bid security / earnest money
 of 2.5% of total value of bid in form of pay order / Call Deposit in favour of
 the Director Plant Protection, Agriculture Extension Sindh, Hyderabad in
 sealed envelop. Tender without bid security will not be entertained.

- Bids will be open publicly by Technical Committee on 11-03-2013 at 12-00
 Noon in committee room of Agriculture Extension Sindh, Hyderabad in
 presence of interested bidders, their representatives who choose to attend.
- The Competent Authority reserves the right to increase / decrease the Nos / quantity of stores subject to the provision of Sindh PPRA rules.
- The procuring agency may reject all or any bid subject to the relevant provision of PPRA rules.
- The bidder must quote rates including all the taxes and other charges if there is any.

- The bidders are requested to give their best and final prices as no negotiations are accepted.
