No tender will be sold on the tender opening date.

In case the date of opening is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time as mentioned.

The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction is made by the contractor himself then each correction must be initialed by the contractor: otherwise the tender are liable to be summarily rejected.

Tender documents can be had/obtained after uploading of notice on Website of SSPRA/KMC and prior to date of opening.

The contractor shall have to attached the 2% Earnest money for total bid (refundable after finalization of tenders) in shape of pay order of any schedule bank drawn in favour of K.M.C with the tender documents failing which the offer will be treated as cancelled.

Tenders will not allowed to be dropped after the schedule time and that unsealed covers/envelop shall not be entertained as valid tender.
