

2. In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 29-04-2013 and the tender documents will also be available upto 26-04-2013.
3. The tender documents will be issued to the firms on submission of application in their original letter head alongwith original paid challan in the prescribed account of KMC for tender cost as mentioned above. This challan can be obtained from the office of tender sale as mentioned in this NIT.
4. The Bid Security as mentioned above in shape of pay order in favour of K.M.C shall must be enclosed with tender documents without which the tender will be treated as cancelled.
5. The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will be not accepted. In addition the bidders must furnish the documentary evidence against each eligibility criteria as mentioned above and minimum qualification criteria as mentioned the bidding documents. Otherwise their tender will be summarily rejected without consideration of their bid amount.
6. The successful bidder shall furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 2% of sanctioned cost. This guarantee will be released after completion of work.
7. An amount equal to 8% from each bill will be deducted as Retention Money, which will be released after successful expiry of maintenance period.
8. All the tender shall be dropped on as per above Schedule up to 02:00 p.m and will be opened by the Tender Opening Committee in the Office of the Sr. Director, Cultural Sport & Recreation, Room # C-315, 3rd Floor, Civic Centre, Gulshan-e-Iqbal, Karachi at 02:30 p.m in presence of the contractor who wish to be present.
9. In case the date of opening declared as a public holiday by the Government, or non working day due to any reason, the next official working day shall be deemed to be the date for sale or submission and opening of tenders, as the case may be. The time & venue will remain same.
