Only those bids, which comply with the each qualification criteria attached with the Part-A of Tender Documents (Technical Proposal) shall be declared responsive bids and there financial bid will be opened otherwise the same will be declared as non responsive / rejected and their financial bid will be returned unopened.
- Bid Security: Bid Security as mentioned above in shape of pay order or bank guarantee or Insurance guarantee (on specified Performa) in favour of KMC shall be enclosed as follows: -
