The first envelope shall be marked as "TECHNICAL PROPOSAL" and second as "FINANCIAL PROPOSAL" in bold and legible letter to avoid confusion under the relevant provision of Rule 46 (2) of SPP Rules, 2010.

The new bidder who wish to under take the work also have to provide an statement of his Bank account for last three financial years showing at least one transaction of Rs:10 .000 (Million) Financial Stability Certificate obtained from schedule Bank and Income Tax Certificate issued by Income Tax Department.
5. Character certificate from Station House Officer (SHO) of concerned Police Station to the effect that the applicant is not involved in any criminal / defalcation case.
