

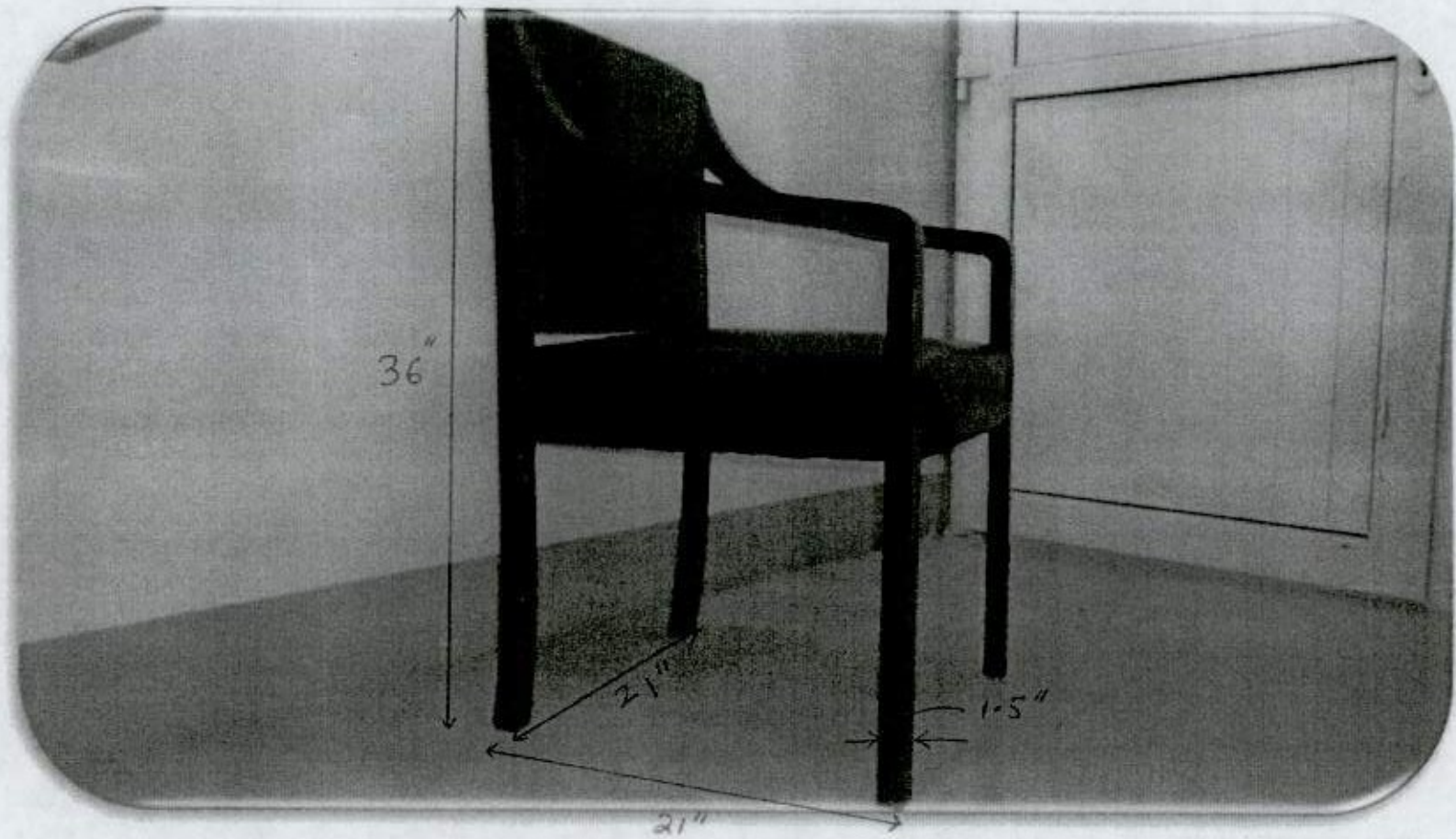

Supply of two seater sofa, whole frame made with shesham wood with first quality foam 4" on seat & 4" thick back foam covered with approved quality leatherite complete in all respects & entire satisfaction by the Engineer in charge. - The tenders will be received backup to **03-05-2013 at 11:00** and will be opened on the same day at **12:00hrs** in the presence of Purchase Committee and the bidders or their authorized representatives who wish to be present.
- Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- Amount of the tender is below Rs.01 Million.
- Conditional tender and tender without bid security shall not be considered.

- g) Delivery time will be 10 days starting after the issuance of supply order.
- h) GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
- i) The procuring agency may amend quantities / reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules 2010.
