3. The Tender Form may be collected from the office of the Deputy Commissioner, Sukkur on payment of Rs.1500/- (Non-Refundable).
4. The Rates of required items should be typed in the tender form and sealed in an envelope addressed to the Deputy Commissioner Sukkur.

Sealed tender will be delivered upto 11:30 AM and received upto 12:00 Noon on 07th May 2013, and will be opened on the same day at 1:00 PM in the office of the Deputy Commissioner Sukkur in the presence of bidders/Firms/Contractors who wish to be present. The tenders received after 12:00 Noon on the above mentioned date will not be considered.
6. The successful bidders will supply the Procured items within one month from the issue of the supply order.
7. The successful bidders will not claim any increases in rates, quantity or period of supply during the currency of the contract.
