Incomplete / Conditional tenders will be not accepted. In addition the bidders must furnish the documentary evidence against each eligibility criteria as mentioned above. Otherwise their tender will be summarily rejected without consideration of their bid amount.

6. The successful contractors, whose tenders are accepted, will have to obtain adhesive stamps from Assistant Superintendent of Stamps, Govt.of Sindh, Karachi on payment of stamps according to Schedule prescribed in the Sixth Finance act 1996 amended rule 2009 and sign the agreement.
