# **TERMS OF REFERENCE (TOR)**

## **Research Consultant**

**Position: Early Learning Program-Research Consultant**

**Project Title: "Research on Effects of ELP Intervention at School Level"**

### **1. Background**

The Early Learning Program (ELP) was initiated by the Sindh Education Foundation (SEF) in 2008 through funding by the Education and Literacy Department, Govt. of Sindh. The program is based on the concept of Early Childhood Education (ECE) and focuses on the development of early learning practices. The program focuses on qualitative reforms and increased participation in 5 districts, namely, Ghotki, Khairpur, Noushehro Feroz, Tando Muhammad Khan and Badin. 150 schools and 10000 children have so far benefitted from this intervention.

While *katchi* classes is not a novel concept, and exist in public schools, the present practice does not fulfill guidelines and objectives as underlined by ECE concepts. ELP, through establishment of ECE classrooms in public schools, aims to foster an environment conducive for early learning. In particular, the program focuses on providing training to teachers, to familiarize them with the ECE concepts.

### **2. Rationale**

In order to strengthen early childhood education, and provide an in-depth analysis of context, extensive field research is required. The main purpose of the research consultancy would be to contribute to the knowledge base of early learning education in the context of Pakistan, and in Sindh in particular. The outsourcing of the research would allow for third party validation, and would help to design and prepare an effective strategy for the future.

### **3. Scope of Work- Objectives and Research Questions of the Study**

The Early Learning Program is primarily focused on developing early childhood centers in government schools to initiate an active and healthy learning environment. Training and orientation to teachers was provided to teachers under this Project. The intervention is confined to *katchi* class although some support was provided to teachers of grade I and II in the past. The inclusion of ELP in schools also suggests an impact on other classes' students and teachers which requires further study. Therefore this study aims to:

- Understand the impact of ELP initiative at various levels: classroom, school and community etc.
- Assess the impact of ELP intervention at behavioral, administrative and pedagogical levels in the schools, particularly beyond *katchi* level
- Explore stakeholders' perception of ELP initiative in schools.
- Identify challenges faced by the ELP program during its first phase of implementation and its impact on the possible expansion of the program.
- Explore the willingness of schools to expand child-centered qualitative reforms to the primary level.

### **4. Responsibilities of Consultant/Deliverables**

The study will be assigned to a single individual. In light of the above objectives, the consultant is required to:

- 1) Develop a research proposal (including research question(s), research methodology, sample design, data collection tools and work plan)
- 2) Undertake all necessary technical, administrative and logistical activities for his/her research including data collection, analysis, report writing as well as coordination with field staff (hired solely by consultant if required).

All instruments, data (soft and hard form) along with report will be delivered to SEF. The report will broadly consider the impact of ELP program, and the possible expansion of child-centered learning up to the primary level.

The work of the consultant will be considered complete after all stakeholders have agreed to the research proposal and report and they are unanimously approved.
