Bidders are directed to submit attested evidence of their PEC registration for the year 2011-2012 with bidding / tender documents.
2. Pay order of 2% Earnest Money as mentioned above to be drawn from any schedule Bank in favour of (Defunct) Town Municipal Administration Landhi should be attached with tender documents without which no tender will be accepted.
3. The Contractor must mentioned their complete and correct present address in tender document and quote the rates both in words and figure. Incomplete /conditional tender will not be accepted.
4. All the tenders shall be dropped in the Box placed in the office of the Chairman Tender opening Committee on or before 09-07-2013 up to 01.00 P.M.
