- Blank tender forms can be collected from the office of Manager (Admin & Accounts), UCG Project Thar, upto 05 July 2013 at 12:00 Noon, during office hours after depositing the tender fee amounting to Rs.200(Non Refundable) in the shape of pay order in favor of Accounts Officer, UCG Thar Project, Islamkot.
- The tender documents will be received back upto 06 July 2013 at 11:00 and will be opened on the same day at 12:00hrs in the presence of Procurement Committee and the bidders or their authorized representatives who wish to be present.
- Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- Bids validity should be for one year on following terms and conditions;

- i. Quotation should be inclusive of all taxes and valid for one year i.e 2013 – 14 from the date of signing of contract.
 - ii. Necessary certificates of accreditation / registrations, i.e. ISO certifications / GST / NTN should be attached with bid.
 - iii. Successful party has to sign the contract with the UCG for one year (2013 – 14)
 - iv. Payment will be made on monthly basis after receipt of original bill.
 - v. In case of termination of contract three months notice will be given by either party.
- f. Amount of the tender is below Rs.01 Million.
- g. Conditional tender and tender without bid security shall not be considered.
- h. Work order will be issued periodically as per requirement of UCG project under the limit of total required quantity per year.
- k. Analysis Report should be submitted back within 10 days after the issuance of work order / receipt of water samples at labs premises.
- l. The procuring agency may reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPP Rules 2010.
- m. Tender envelope should bear the tender No UCG/Tender/Chemistry-85/13 and **Tender for Chemical Analysis.**
