- 03. Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- 04. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.

- 05. Amount of the tender is below Rs.01 Million.
- 06. Conditional tender and tender without bid security shall not be considered.
- 07. Delivery time will be 10 days starting after the issuance of supply order.
- 08. GST/Income Tax Exemption Certificates, as the case may be, must be accompanied with the tender.
- 09. The procuring agency may amend quantities / reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules 2010.
