Moreover, it has been observed that your office had also invited bids for the procurement of "Stretcher Cum beds with mattress" vide NIT No.MS/ ASH/ AAO/ 673/ 2013 dated 28.05.2013 and NIT No.MS/ ASH/ DDA/ 720/ 2013 dated 17.06.2013.

2. In view of the above, it is advised to furnish:

- (i) compliance of this Authority's letter dated 17.07.2013;
- (ii) notification of procurement committee as per Rule-7;
- (iii) clarification in respect of anomaly in the Comparative statement and Bid Evaluation Report;
- (iv) clarification to how NIT for procurement from the donation of 2012-13 be issued in the year 2013-14?
- (v) Current status of NITs dated 28.05.2013 and 17.06.2013;
