- NOC from Excises and Taxation Department with regard to payment of professional tax.
- Bid Security in shape of pay order / Demand Draft not below 2% and not exceeding 5% of the total cost of the bid.
- An affidavit on stamp paper of Rs: 50/- duly authenticated by Notary Public to the effect that the firm or contractor has never been black listed from any Government, Semi-government Department or Private Department, not bank loan, Government dues defaulter and not indulge in any criminal activities.
- Photostate attested copy of valid Computerized National Identity Card of the contractor.


The successful contractor / bidder will have to credit security deposit within one week before the start of contract.

The contractor / bidder will have to execute an agreement on a stamp paper to the effect that he accepts the terms and conditions of the contract.

In case of infringement of any of the condition the contract will be resigned at the risk of the contractor /bidder and he will be liable for the forfeiture of security deposit in part or whole, if he fails to abide the conditions.


