

- 2- The Tender document will be issued to contractor on the submission of written request on letter head and on payment of non-refundable cost of tender price through pay order from any schedule bank in favors of TMA Ghora Bari, Thatta, as mentioned above. The photocopy of PEC Registration certificate should be enclosed with the bid otherwise the tender will be rejected. No tender will be sold on the tender opening date.
