The project is intended to control the ground water table and to drain out the stagnant pools of non gravity pockets within the area of Drainage Division LBOD Shaheed Benazirabad.

The proposals submitted by the intended contractors/firms includes but not limited to the below information.


1. Name of Firm along with permanent address, telephone numbers & E-mail address.

3. List of work executed during the last 10 years specially in drainage sector or ground water projects along with estimated cost and name of client.

4. List of plants, equipments, transport and machinery available with the firm, especially Rig machines for drilling of tube wells & pilling work of bridges in the areas under water.
5. Copy of valid certificate of Pakistan Engineering Council in category C-3 (upto 100 Million).
6. Affidavit that the contractor has never been blacklisted by any agency.
7. Proof of financial capability including income Tax return of last 03 years.
8. Credit line certificate from the reputable bank.
9. Any additional information with supporting documents.

The Technical Proposals will be considered and evaluated in accordance with SPRA Rules 2010. The interested contractors/ firms may obtain any further details regarding the project on any working day before the submission of the proposals. The Technical proposals in English shall be submitted in three (03) Copies to reach the office of the undersigned in sealed cover and not later than closing of office hours.
